BE STARTING A BUSINESS IN A ROAD CARGO TRANSPORT IN DOMESTIC TRAFFIC

Includes:

- 1. Administrative procedures (14 administrative procedures) under the jurisdiction of 7 authorities
 - Serbian Business Registers Agency;
 - Statistical Office of the Republic of Serbia;
 - Tax Administration;
 - Central Registry of Compulsory Social Insurance;
 - Republic Health Insurance Fund;
 - Ministry of Construction, Transport and Infrastructure;
 - Road Traffic Safety Agency
- 2. Administrative requests (2 administartive requests) under the jurisdiction of the Ministry of Construction, Transport and Infrastructure Department for Inspection Affairs

BE - EMPLOYMENT

Administrative procedures (13 administrative procedures) under the jurisdiction of 3 authorities:

- National Employment Service
 (9 administrative procedures)
- Central Registry of Compulsory Social Insurance (2 administrative procedures)
- Republic Health Insurance Fund
 (2 administrative procedures)



BE PAYING TAXES

Administrative procedures (36 administrative procedures) under the jurisdiction of 2 authorities:

- Tax Administration
 (34 administrative procedures)
- Business Registers Agency
 (2 administrative procedures)


